Indiana Supreme Court Offering Free Mortgage Foreclosure Training

The Indiana Supreme Court, ICCLE, and Indiana Pro Bono Commission have partnered to offer civil mediators the opportunity to receive free training as mediators in residential mortgage foreclosures. The training includes a replay of a 3-hour foreclosure-based DVD, a free lunch, and then an additional 3-hour session of live mediator training. Participants completing the training will earn up to six hours of CLE and CME and one hour of Ethics credit. Mediators who complete the training earn the distinction of becoming an Indiana Registered Foreclosure mediator. Participating mediators will be asked to pledge pro bono mediation services for at least two residential mortgage foreclosure cases. About that Mediate.com E-Mail

Recently, Mediate.com has been circulating an offer to mediators to become "Mediate.com Certified Mediators". The IAM Board discussed this at their last meeting without coming to any definite conclusion, other than to note that this will provide the organization with a different revenue stream than they have previously had. Certification requires at least 100 hours of mediation training and 500 hours of mediation case experience. Certified mediators must specifically designate the areas of their mediation experience including how many cases in each specific practice area have been done. Finally, at least 12 hours of CME training per year are required to retain the designation. The cost of the certification review is \$150 and the renewal fee is \$50/year after certification.
