2010 Indiana Legislative Session

The 'short' session of the Indiana General Assembly is winding down and although several measures involving mediation were introduced, the press of other business may make passage uncertain.

SB 59 - Family Law - Grandparent right of visitation - allows Courts to order a grandparent or great-grandparent party seeking visitation rights to pay a reasonable amount to the other party for the costs of attorney fees and mediation to the other party incurred to maintain or defend the action.

SB 159 - Technical corrections bill - similar to SB 222 below.

SB 222 - Technical corrections bill - Education - children of certain members of the military - requires the Interstate Commission to adopt a rule providing for both mediation and binding arbitration to settle disputes subject to the compact which arise among member states.

HB 1055 - Companion bill to SB 59 filed in the House of Representatives.

HB 1074 - Insurance - allows mediation to be used to resolve a dispute between an insurance company and a company that provides dialysis on a contracted basis if the contract contains a dispute resolution provision.

HB 1121 - State Contracting with Disabled Veterans - the bill provides a 3% price preference for a service-disabled veteran small business for purposes of state public works contracts, state purchasing of goods and services, and state highway contracts. The IDOA is allowed to settle grievances between contractors and state agencies and mediation is permitted to be used to settle disputes between state agencies and contracting authorities.

HB 1240 - Insurance - allows an independent public accountant to enter into an agreement with an insurer to have disputes relating to an audit resolved by mediation or arbitration.

HB 1351 - Limited partnerships and liability companies - enacts the Uniform Limited Partnership Act and the Revised Uniform Limited Liability Company Act governing LLC's. Allows mediation and arbitration to be used in the settling of disputes while winding up the affairs of a Limited Partnership or an LLC following dissolution.

IN AG's Consumer Protection Division to Offer Pro Bono Mediation Opportunity

On March 27, 2010, the Indiana Attorney General's Consumer Protection Division will be hosting its first annual "Mediation Day". During the program, staff mediators and volunteers mediators from across the state will work alongside law school students trained in mediation. The goal is not only to provide 'hands on education' and facilitation of dispute resolution to assist both consumers and businesses in working out differences in consumer complaints filed with the Attorney General. The effort is being headed up by Abigail Kuzma, Chief Counsel of the Consumer Protection Division. Cases involving complaints and respondents have been chosen primarily in the area of car and home improvement issues. Two sessions will be held - the first from 10:00 am - Noon and the second from 1:00 pm to 3:00 pm. Sessions will be held at the Indiana Government Center South - 200 West Washington Street. The RSVP deadline was March 1, but if sufficient response has not been received, they may be willing to include last minute participants.
